



DigitalShipper is pleased to announce that DigitalShipper 5.9.14 has been released! This release includes enhancements, improvements, and minor bug fixes. Highlighted in this document are the key changes.

IMPORTANT NOTE:

The latest DigitalShipper version requires:

- An updated license file be imported that is compatible with DigitalShipper 5.9.12 and above. The updated license must be obtained before starting the DigitalShipper update.
- The database to be a minimum of 5.9.6. Customers using DigitalShipper 5.9.5 or earlier, need a database update to 5.9.6 before updating to the latest version.

UPDATES IN DIGITALSHIPPER 5.9.14

ONTRAC (CAL)

- Updated workflow for 'OnTrac WS – West' accounts' closing status to show "Sent".

USPS E-POSTAGE (PWT)

- Added password attribute to rate, ship, void, and scan form transactions.
 - Passwords are assigned by the USPS and will need to be added to PWT in DigitalShipper Management Console.

2024 CARRIER COMPLIANCE RATE & SERVICE UPDATE

- 2024 carrier compliance rate and service update for:
 - United States Postal Service Carrier (POS), effective January 21.

FEDEX (FDX)

- Minor adjustments for FedEx Dangerous Goods for FWS.

ONTRAC (CAL)

- Adjustment for 'OnTrac WS – West' password format.

USPS E-POSTAGE (PWT)

- Adjustment to prevent shipping with ePostageV1 account type, which is no longer supported.

2024 CARRIER COMPLIANCE RATE & SERVICE UPDATE

- 2024 carrier compliance rate and service update for the following carriers:
 - UPS
 - Spee Dee Delivery (SDD)

DIGITALSHIPPER LICENSES

- Updated format for DigitalShipper license files.
- DigitalShipper 5.9.12 and above require the updated license format.
- Existing license files are not compatible with DigitalShipper 5.9.12 and above.
- The updated license file must be imported after the DigitalShipper update is performed, before shipping can take place.

UPDATES IN DIGITALSHIPPER 5.9.11

ONTRAC (CAL)

- Carrier compliance update – "OnTrac WS - West".
 - Added web services integration, referred to as, for accounts.
 - Accounts with the new "OnTrac WS - West" account type have transactions submitted via the OnTrac Web Services.
 - Existing customers should migrate to "OnTrac WS – West" as soon as possible.
 - Legacy OnTrac accounts will not receive the updated 2024 rates and routes.

UPS

- Carrier Messages
 - New DigitalShipper App Link created to better automate checking and processing UPS carrier messages.
 - Requires a new task setup in Windows Task Scheduler.
 - UPS carrier messages can also be manually checked and processed from the Carrier Messages page in DigitalShipper Management Console.

FEDEX (FDX)

- Minor adjustments for FedEx International Dangerous Goods.
- Minor adjustments for FedEx Duty and Taxes special service.

PITNEY BOWES INC (PBI)

- Added option to indicate "minimal" or "complete" address validation when generating labels for domestic shipments.

DIGITALSHIPPER CLIENT MANAGER

- Added support for Rice Lake iDimension Series and Postea QubeVu Dimensioner.
- Enhanced functionality to allow for the DigitalShipper Client Manager to use a configured custom port for specific workstations.

- Expanded destination service area.

FEDEX (FDX)

- Minor adjustment to support EORI number length.

UPS

- Carrier compliance update for UPS SurePost:
 - Updated dimensional surcharge rules.
 - Changes to AK/HI and US Territory shipments related to new USPS Ground Advantage.
- Adjustment for Peak Demand surcharges workflow.

UPDATES IN DIGITALSHIPPER 5.9.7

UPS

- Fuel Surcharge
 - Fourth category added for International Ground services.
 - Existing categories renamed for better clarity.
 - New support for automated processing of the UPS weekly fuel surcharge entries in DigitalShipper Management Console.

FEDEX (FDX)

- Adjustment for FedEx Dangerous Goods workflow.

UPDATES IN DIGITALSHIPPER 5.9.6

UPS

- New UPS account number format.
 - Allowing for additional possible alpha-characters in account numbers.
- Workflow update for PVA Registration Number special service (applies to both UPS and UMI).

PITNEY BOWES INC (PBI)

- New compliant carrier.
 - Compliant postal solution with two types of services: PB Expedited and PB Standard.
- Any existing generic carrier using the PBI carrier abbreviation will be renamed automatically.
